Privacy Policy

The Privacy Policy describes how your information is collected, used, and disclosed by Lead Wallet and our subsidiaries and affiliated companies ("Lead Wallet," "we," or "us") when you access our website, mobile applications, or services; subscribe to mailing lists or other events, or interact with us on networking websites where we have an official presence. This Policy will not be applicable where we link to a different Privacy Policy.

Information Collection

We collect information about you in the following ways:

1. Information provided by you:

We collect information like name, email address, phone number, date of birth, demographic information, mailing address, government ID, biometric data, photos, and any other personal information that you decide to provide to us directly.

2. Information collected by using our services:

We automatically collect your information when you use our Services, and we may associate this information with the ones that we collect otherwise. Examples may include: (a)

Transaction Information: When you use our applications, we collect information about your transactions, which includes, but is not limited to, the transaction amount, currency exchange rate, destination wallet address for any sent cryptocurrency, time, date, and location.

- (b) Registration Information: When you visit our site or use our application, certain information such as IP address, connection time, computer's operating system, browser type, language, and sites visited before accessing our website will be logged automatically.
- (c) Information collected by cookies: We use various technologies to collect information, which may include placing cookies on your computer or mobile device when visiting our website. Cookies are small data files that a website stores on the hard drive or in the device

memory. Among other things, they help us improve our services and your experience, find out which features are the most popular, and count visits to our Services.

- (d) Information collected by web beacons: We may collect information using web beacons. Web beacons are electronic images that can be used on our website or emails. We use it to provide cookies, track visits, understand usage and communications, and determine whether an email has been opened and applied.
- 3. Information collected from other sources:

We may also receive your information from other sources and link or combine it with the information we collect about you.

Information Use

The information collected through our Services is used for the purposes described or disclosed in this Policy. For example, your information may be used for:

- 1. working and improving our Services;
- 2. protecting our rights and property;
- 3. monitoring and analysis of trends, uses, and activities related to our Services;
- 4. answering your comments and questions and providing customer service;
- the provision and delivery of products and services and the sending of relevant information, including confirmations, notifications, updates, requests, alerts, and administrative and support messages;
- detection, investigation, and prevention of fraudulent transactions and other illegal actions;
- 7. achieving any other goal for which the information was collected.

Advertising

Lead offers free advertising services. We therefore enable advertisers to run campaigns through our services. The information you provide will help you better target and position your ads. However, we will never share or sell your personal information to advertisers without your prior consent.

- Google as a third-party provider, uses cookies to place advertisements on your website.
- With the DART cookie, Google can show your users ads based on their visits to your website and other websites on the Internet.
- Users can deactivate the use of the DART cookie by visiting the Google ad and content network privacy policy

Google Analytics

Our site can generate and track the statistics of Google websites with the use of Google Analytics. As a result of this and the fact that Lead supports display advertising with Google, the following must be understood:

- Third-party vendors like Google make use of first-party cookies (example, Google
 Analytics cookies) and third-party cookies (example, DoubleClick cookie) together to
 report how your ad impressions, other uses of ad services, and interactions with these

- Visitors can opt-out of Google Analytics for Display Advertising and customize Google

- Third-party vendors like Google may show your ads on websites across the Internet.
